2024 AKA All Sports Camp Waiver and Cancellation Policy

WAIVER OF LIABILITY/AUTHORIZATION (Payment and Cancellation Policies Below):

In consideration of participating in AKASPORT activities and by completing this form, on behalf of myself and my children, heirs, assigns, personal representative and estate, I hereby agree to release and discharge all members of the Active Kids Association of Sport ("AKASPORT") staff, its agents, officers, volunteers, and any other party involved in the organization and administration of the AKASPORT programs, from any claims, liabilities, causes of action, losses, costs or expenses, including all claims for personal injury, wrongful death, and property damage, caused by, or arising out of, the participation in the AKASPORT programs.

I hereby declare that the enrolled applicant is in good health and in the case of emergency, I grant permission for my child to be given medical treatment at a local hospital. By filling out this form and registering online, I accept all responsibility and assume all costs that may be incurred in the event of an injury or accident. My child has my permission to be transported by AKASPORT as needed for field trips.

I also understand that photographs and videos will be taken throughout the program and I hereby authorize that they may be published publicly without any further consent from me.

PAYMENT POLICY:

Payment plans are available for all AKA Full Summer and Individual Week All Sports Camp programs. When paying the minimum deposit, all credit or debit card information will be kept safely on file. All payments must be completed by July **15**, no exceptions. If questions or concerns, contact info@akasport.org.

If you have not paid IN FULL by July 15, 2024; your child will not be allowed to participate in summer camp activities until the outstanding balance has been paid. You are responsible to ensure that you have paid in order for your child to attend camp. This is vital to AKASPORT's ongoing operations.

CANCELLATION POLICY:

For Full Summer Packages (10, 11 and 12 week packages):

- Cancellations prior to April 1 will receive a refund of amounts paid, minus a \$50 cancellation fee to cover administrative expenses.
- Cancellations after April 1 will receive a refund for everything paid, minus the initial deposit of 15% of the total program fee.
- If you remove more than 2 weeks from your 10 week package (in other words, fall below 9 weeks within a
 package registration), you will be subject to the individual week rates and you will lose your early bird
 discount.
- If outstanding balances surpass the last day of camp, a 5% increase will be applied every two weeks, until
 the outstanding balance is paid off.
- No refunds will be processed after September 1st.

For Individual Week Registrations (Weekly registration up to 9 weeks):

- Complete cancellation from the AKA All Sports Camp prior to April 1st will receive a refund for amounts paid, minus a \$50 cancellation fee.
- Individual week cancellations (reducing total program weeks) made prior to April 1st will receive a refund for the canceled weeks so long as participants remain registered for at least one week.
- Individual week cancellations made after April 1st will receive a refund minus 25% of the canceled weeks.
- If outstanding balances surpass the last day of camp, a 5% increase will be applied every two weeks, until the outstanding balance is paid off.
- No refunds will be processed after September 1st.

 $\underline{\mbox{Absence Policy}}.$ There are no refunds for individual days missed due to illness or absence.

- If more than 3 days are missed within one week due to illness or family related emergency, please contact us at AKASPORT (info@akasport.org) to discuss refunds or credits to your account. You must notify us a **full** week prior to the week you have paid for if your child is going to be absent in order to receive a refund for the amounts paid, minus 25% (see individual week cancellation policy).
- If you are unable to attend weeks you have signed up for you are still obligated to pay for those weeks if you have not notified us one **full** week in advance.
